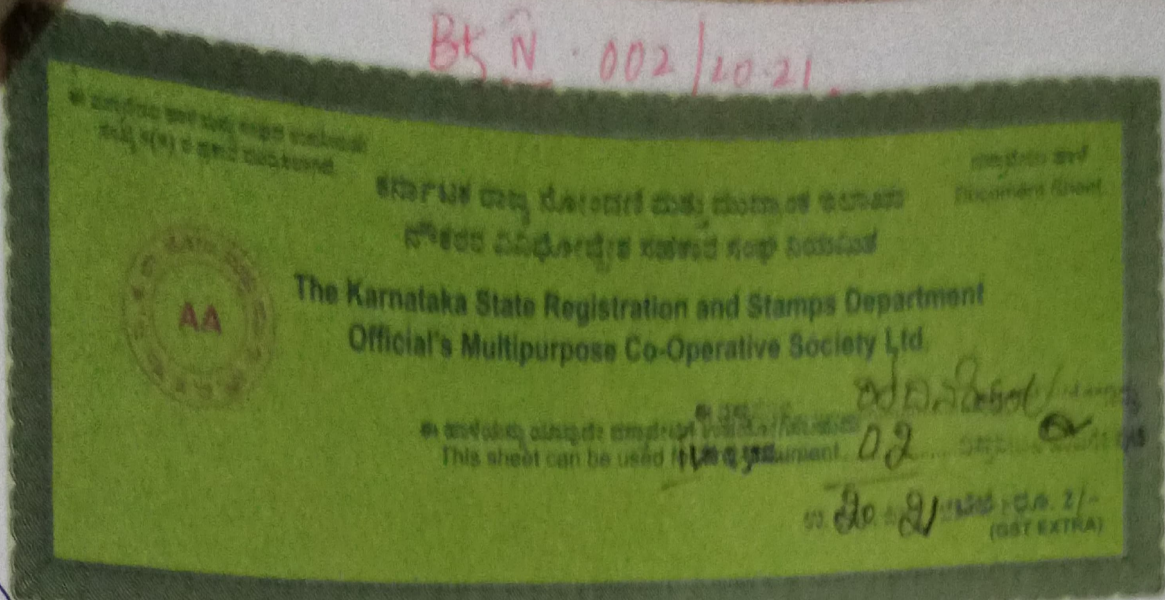

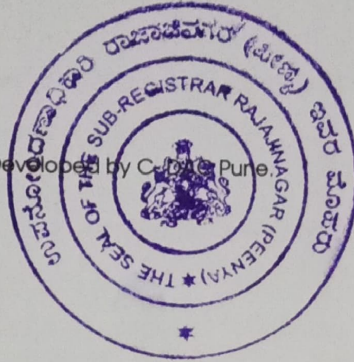

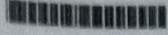
ARTICE-III AIMS AND OBJECTIVES OF THE TRUST

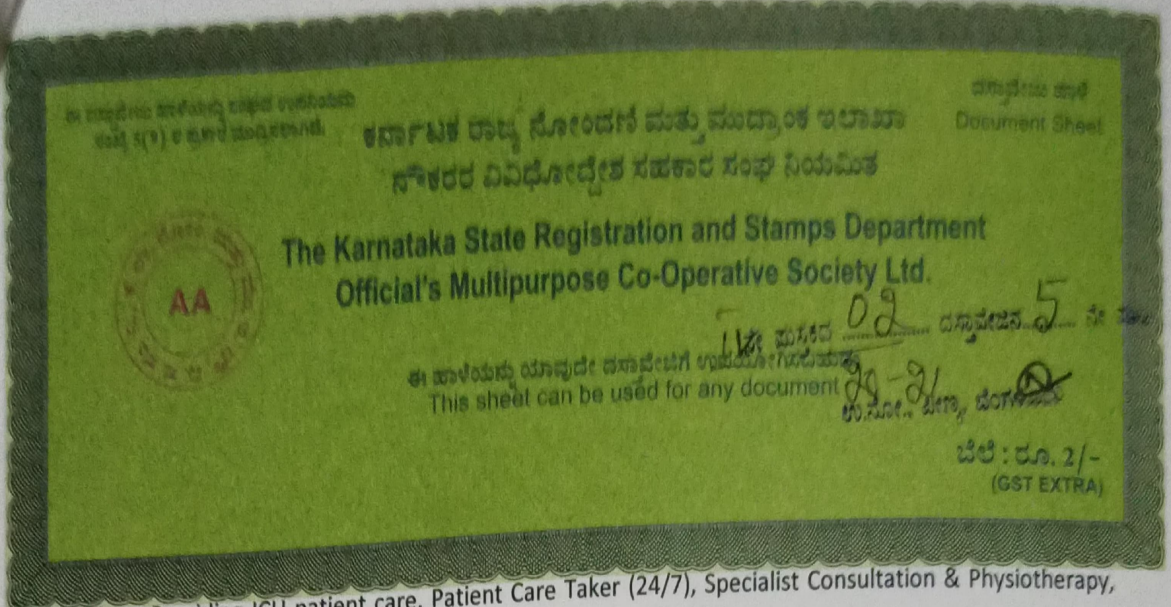

- iv. Providing home nursing services to male and female, health care attenders, old age people care, baby care, physiotherapy, blood test, doctor visit, oxygen supply, medications & injections, medical equipment supply, pharmacy, jobs for nurses, attenders (M/F) and maternity care.
- v. Providing formal and non-formal assistance to age old men and women.
- vi. To arrange and conduct meetings, classes, seminars, workshops, conferences, campaigns, demonstrations, events, and lectures and to provide opportunities for study and research and to make the findings available to anyone who can use them for the benefit of mankind.
- vii. To offer and provide consultative and professional services to age old men and women and other institutions.
- viii. To offer cooperation to and actively engage in mankind instruction, spiritual development and promote cultural understanding and to offer assistance and support to such Trusts or Societies and to respond to their invitation to help in all possible ways in keeping with the objects of the Trust
- ix. To raise funds through donations, by request, by public subscription, by issuing appeals and by accepting contributions from State or Central Government, individuals, philanthropic bodies, religious bodies, institutions, local bodies and industrial concerns, limited or private, where so ever situated in the Union of India or abroad to fulfill the objects of the Trust.
- x. Taking up programs of environmental awareness and development for ensuring on a sustainable basis.
- xi. To organize lectures, seminars and exhibitions.

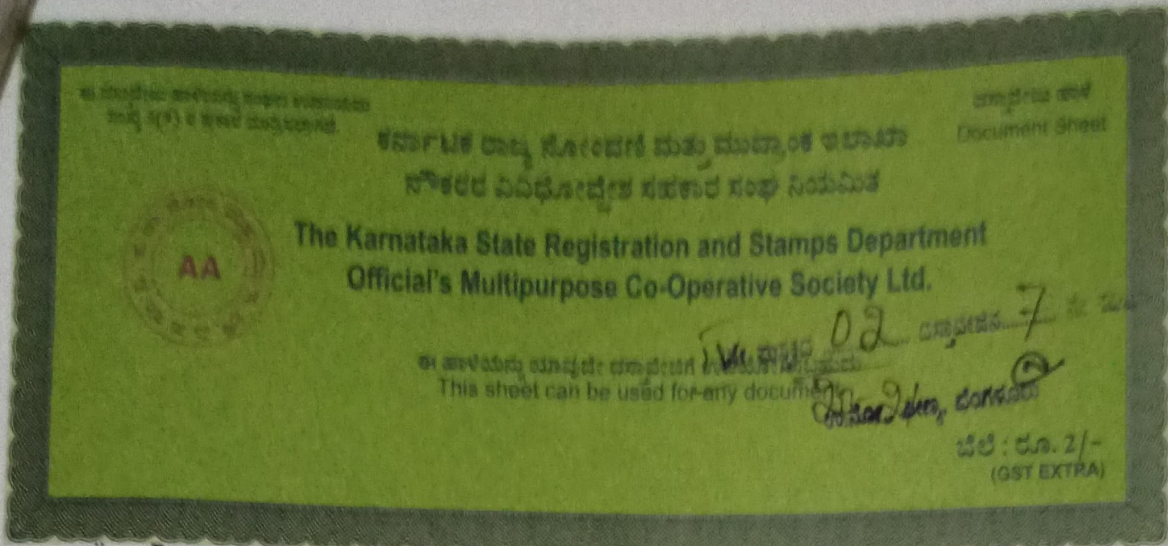

- xii. To grant scholarships, stipends to institutions and organizations in keeping with the object of the Trust.
- xiii. To establish, Training Centre, and allied old age institutions.
- xiv. To Spread for promotion of Old Age Home and learning in all branches more specifically in home nursing and domestic services.
- xv. To advance Indian Culture and Literature, Service of this Country for the benefit of our Nation.
- xvi. To train volunteers and workers in ideals and practice of the true spirit of the old age home and home nursing.
- xvii. To establish research and training centres for the furtherance of old age home/home nursing in it's various fields and branches.
- xviii. To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- xix. To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- xx. To acquire and maintain the movables and immovable properties for achieving and said objects.
- xxi. To advance any other objects of general public utility.
- xxii. To confer title on eminent personality in the field of old age home, home nursing and domestic services etc.,
- xxiii. **Investment Clause**-The funds of the trust shall be invested in the modes specified under the provisions of sec.13(1) (d) r.w.s 11(5) of the I.T. Act 1961, as amended from time to time.
- xxiv. To start or use television, radio, literature, internet, correspondence courses, satellite dish etc. with the purpose to educate society in understanding of welfare, community health, development, spiritual, family life, human rights and lifestyle that may help improve the society.

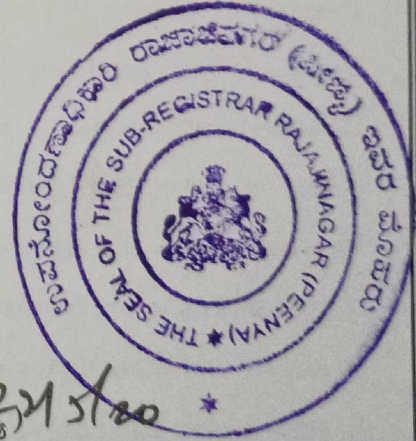

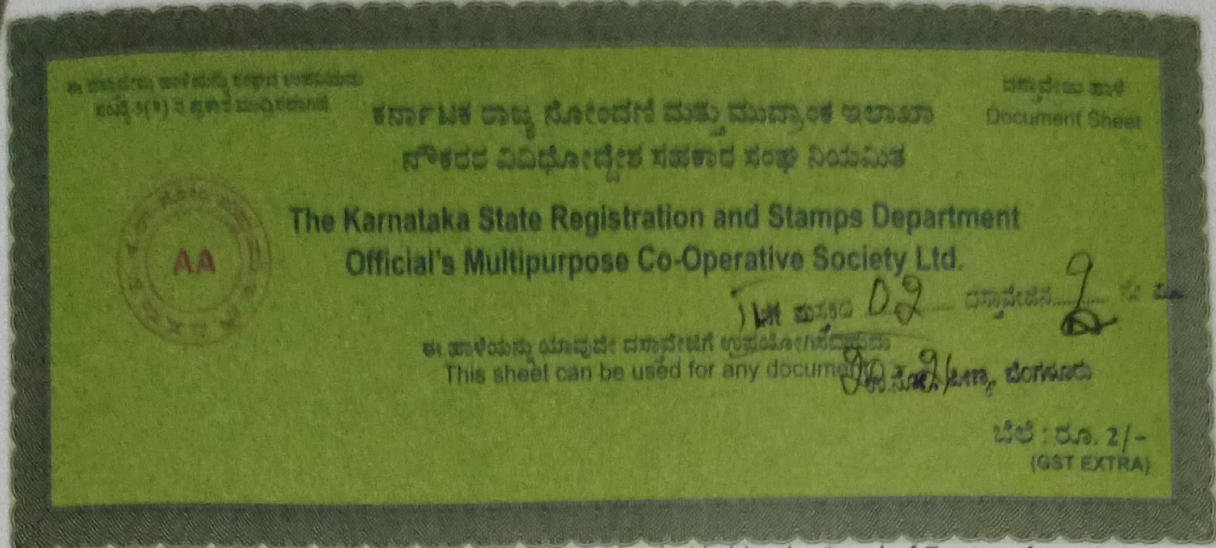

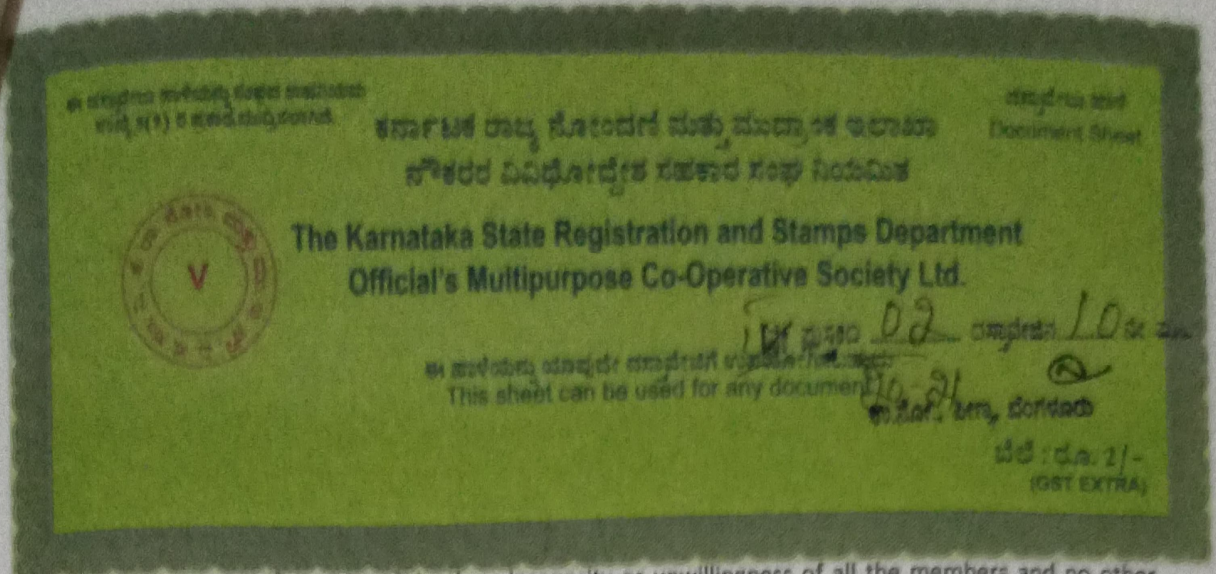
- xxv. To take up any other activities which may be decided by the Board of Trustees from time to time, which are not against the objects and basic principles of this Trust as mentioned in this Trust deed.
- xxvi. To do all such other lawful acts as may be necessary, incidental to or conducive to the attainment of the above aims and objects.

ARTICLE-IV MANAGING BODIES AND OFFICERS OF THE TRUST

- i. The author of the trust here by appoints, nominates and constitutes the Board of Trustees consisting of himself and second, third and fourth parties here in as the trust members of the Board of Trustees.
- ii. The members of the Board of Trustees shall hold office for life unless they retire, as provided here in.
- iii. The total strength of the Board shall not be less than two members and shall not be more than seven members at any time. The members of the Board shall have the right to co-opt one or more persons as members of the Board of the Trustees to fulfill any vacancies, for such periods as they deem fit within the limits of the size of the Board as afore mentioned. A retiring member shall be eligible for a re-appointment. There may be any number of a single formal member as trustee.
- iv. In the event of the number of the Board of Trustees being reduced to one, such a single member may constitute the Board and will have the right to co-opt one or more members to the board provided it is done within a period of three months from the date of such reduction.

- v. In the event of death or incapacity or unwillingness of all the members and no other trustees are appointed, the power of appointment of the trustees shall vest with competent court having jurisdiction where the registered office of the trust is situated.
- vi. Any trustee may retire from the trust by notifying the President of the Board of trustees in writing of his/her intention to retire. The trusteeship for this member ceases on the acceptance of the request by the Board, or on the lapse of 90 days from the date of receipt of the notice by the President, whichever is Earlier.
- vii. A Trustee shall forfeit his/her trusteeship position in the trust in the event of his/her death, voluntary retirement, or dismissal, as also when adjusted insolvent, or of unsound mind, or convicted of any offence involving moral turpitude, or consecutive absence with put leave or absence from four board meeting of the trust. A trustee other than a life member may be dismissed of his/her services terminated from his/her trusteeship position, by the Board of trustees particularly if he/she states or it provided that he/she does not believe in the aims and objectives of the trust, or he/she attempts to subverts or subverts the activities of the trust, or engages himself in any acts which are prejudicial to the interests of the trust. The dismissal or termination shall take effect from the date on which the matter has been considered by the Board and effect, which is then communicated to the member concerned by the President in writing. A member of the board of Trustees other than the life member may also be dismissed, provided at least a majority of the members of the Board of Trustees as constituted from time to time give their consent to the removal of such member.

- viii. The office of the members of the Board of Trustees shall be honorary and any person holding such office shall not be entitled to draw any remuneration for carrying out such duties, but shall be entitled to reimbursement of actual or estimated expenses incurred by him for attending the meeting of the Board of trustees or attending to the work of the Trust.
- ix. Notwithstanding what is contained above in the article 4 (viii) of the trust, any trustees along with managing trustees will be entitled for reasonable fee where such work involves conservable time and inputs for the services rendered by him/her in the administration of the trust and in enabling the trust to fulfill its objectives. The Board shall authorize reasonable remuneration for these positions. However, in the event of any trustee being contracted to take up any assignment other than that of a trustee, he shall be paid such remunerations as may be approved by the Board of Trustees.
- x. Utilization Clause- The funds and income of the trust shall be solely utilized for achievement of the objects of the Trust and no payment shall be made to the trustee by way of profit, interest/dividend etc.
- xi. The members of the Board of Trustees shall be indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the trust any such expenses, losses and payments shall be borne by the trust and none of the members of the board of trustees shall in anyway be personally liable or responsible for the same.
- xii. A member of the Board of Trustees may be chargeable only for such moneys and securities as he shall actually receive and shall be answerable and accountable for his/her own acts receipts or neglects or default and not for those of other or any

xiii. **PRESIDENT OF THE BOARD OF THE TRUSTEES**

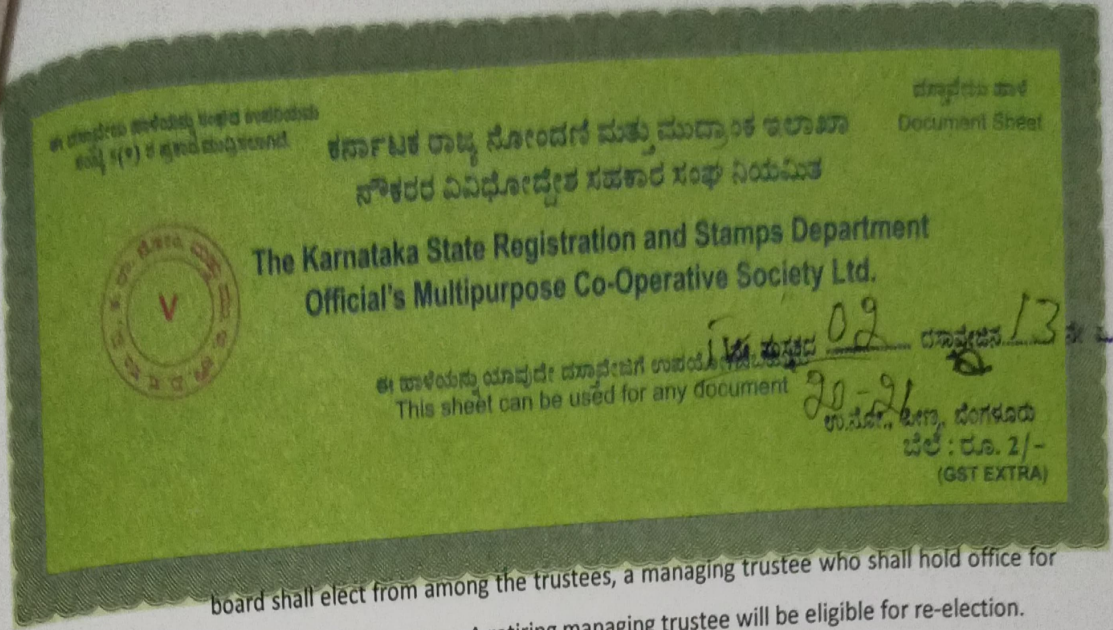
MR. NAGARAJ M, shall be the President of the board of trustees. He shall exercise all powers to decide all matters/ issue and take such action or to suggest such proposal which he deems fit and proper in the interest of the trust. He have the right to call any Board meeting in case of urgency/ necessity. He shall hold office for life or till voluntarily retires. After he retires, the board shall elect from among the trustees a President who shall hold office for not more than three years. A retiring President will be eligible for re-election. At the meetings of the Board in the absence of the President, the members present shall elect a member to reside over the meeting.

xiv. **THE MANGING TRUSTEE AND THE SECRETARY OF THE BOARD**

The managing trustee **MR. MALLIKARJUNA M**, shall be the Chief Executive Officer/ the Secretary of the trust. She shall exercise all powers as may be delegated to her by the board to facilitate the day to day conduct of the affairs of the trust. The managing trustee in matters relating to the meetings, of the board shall act as the secretary of the trust, convene meetings, maintain record of proceedings, etc., shall be the first managing trustee and shall hold office for life or till she voluntarily retires. After her the

- board shall elect from among the trustees, a managing trustee who shall hold office for not more than three years. A retiring managing trustee will be eligible for re-election.
- xv. The Board of Trustees may appoint either one of members or any other person qualified for the work, as treasurer of the trust for such time and such terms of appointment as determined by it. The treasurer shall advice the Board on all financial matters affecting the working the trust, including the investment of funds shall be the first treasurer of the trust and shall hold office till he voluntarily retires.

ARTICLE-V POWER OF THE BOARD OF THE TRUSTEES

With a view to carry out the objectives of the trust here in above mentioned and to augment its funds and administer them and in discharge of their duties, the Board of Trustees shall have the following powers:

- Examining, scrutinizing, promoting and funding research and studies for the identification of the weaker and disadvantaged section of Indian society such as those in or among the rural areas, urban slums, tribal areas, depressed minority groups, women, youth and children in particular occupations etc., and identifying the strategies, activities and nature of educational assistance needed to help improve the situation.
- Organising or assisting in the conduct of seminars, workshops, courses, training programme, meeting conferences, both on its own or in collaboration with other institutions, organization, agencies or other bodies, in the subject stated herein and grant certificates, diplomas, awards, etc., as needed. Such activity shall be aimed at diffusion of knowledge and experience, creating higher levels of skills, and developing leadership talents and a caring society.

- iii. Publishing or assisting in the writing, printing and publication of special books, periodicals, articles and reports on study and research findings and their distribution in any of several media and organizing book clubs, lending libraries, reading rooms, etc.
- iv. To make donations or contributions for the promotion of the objects of the trust.
- v. To acquire on lease or by purchase or otherwise to sell, mortgage, lease or any transfer in any other manner what so ever, properties, movable or immovable, to construct, education institutions, research centers and or other building to carry out other improvements thereof for the purpose of the trust and to manage and deal with the properties, moveable or immovable and all other assets of the trust and to mortgage them to repay loans or other wise and to deal generally with the assets for the purpose of the trust.
- vi. Employ, train, use terminate services, employment, pay salaries, wages, allowances and other forms of remuneration, take disciplinary action, set up rules and regulations, in relating to all aspects of administration of a trust organization and its offices, and do all such acts as are necessary for the purpose.
- vii. To collect funds by way of donations, subscriptions, grants, presents, contributions or otherwise.
- viii. To enroll patrons, vice patrons, life members, members, and associate members and to frame rules for the various types of membership and rights and obligations, associated there with and collect membership and activity dues. However, none of such members shall have any of the powers of a trustee unless appointed as the trustee.
- ix. Open and maintain bank accounts of any nature in any banks in the name of the Trust and operate them through **MR. MALLIKARJUNA M**, authorized members of the board of

- x. Represent trust in all courts of statutory authorities or government, semi- government and local bodies in all matters for which such representation is required. Delegate any of the powers of the representation and action to any member of the board or others, employees or appointed lawyers, for such time as considered necessary, and revoke vary or rescind such powers as necessary, in the matter of signing applications, or compromising, abandoning or referring to arbitration the whole or any part of the claim by or against the trust, or engaging or taking all other necessary actions.
- xi. To meet all the necessary expenses incurred or to be incurred in connection with creating or executing of this trust and/or in connection with the management of the trust.
- xii. To borrow for the purpose of the trust on the credit of the trust with or without charge and responsibility up on the assets of the trust.
- xiii. To appoint committee, sub-committee from among the members of the board or along with others and assign duties and seek suggestions for the purpose of working of the trust.
- xiv. To apply and use funds for all or any of the objects of the trust or for promoting, furthering or achieving under the object of the trust or for any purpose specified under the objects of the trust.
- xv. To pay out of the trust funds salaries, wages, rent building, maintenance, repairs and other expenses relating to the trust and its activities or its other affairs.

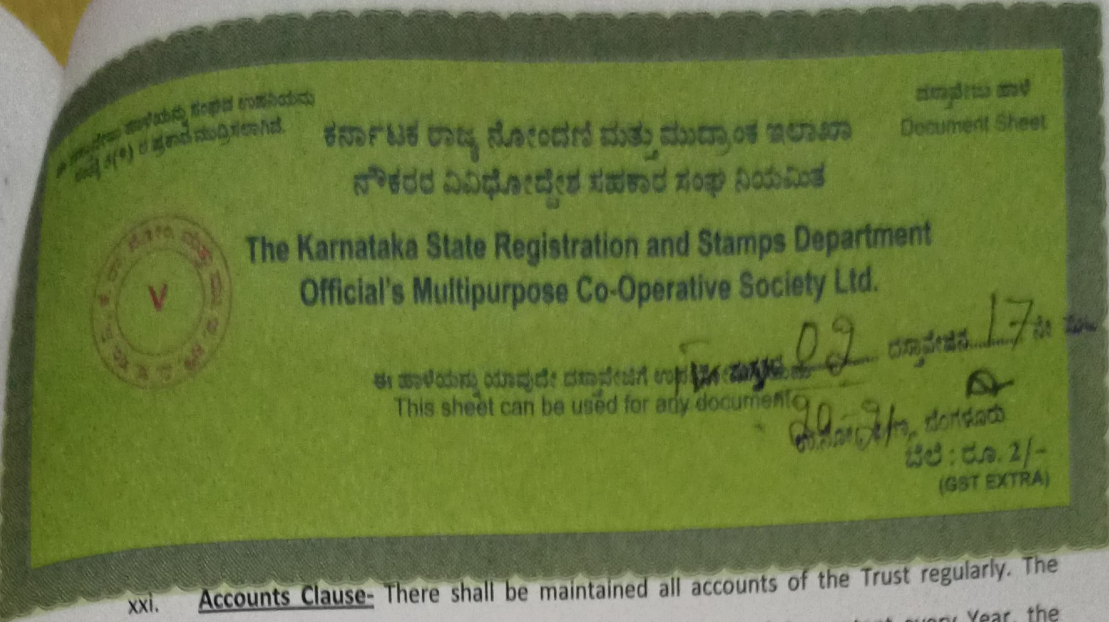

- xvi. **Amendment Clause**-No amendments to the trust Deed/ Memorandum of Association/ Byelaws/ Rules and Regulations shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12, & 13 & 80G of I.T. Act, 1961, as amended from time to time FURTHER NO AMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.
The board of trustees shall be at liberty to add or alter or abrogate any of the provisions of the trust.
- xvii. To undertake and carry on any other work which may deem to the board capable of being conveniently carried on in connection with an existing activity of calculated directly or indirectly for the promotion of the objects of the trust.
- xviii. The board of trustees shall have power to delegate all or any of the powers vested in them by these presents to any other trustees or any other person for the purpose of convenient managing and exercising such power with the notice of the President.
- xix. The powers vested in the board of trustees shall be exercised by resolutions passed in the meetings of the board or by circulation and accepted by a majority of members present in the meeting or acceptance by signature of the majority of the full strength of the board of trustees respectively.
- xx. Any member of the board may call for the convening of the meeting of the board by sending a written request to the managing trustee cum secretary setting out there in the matters to be discussed. The secretary in consultation with the President, the matter of the date of meeting, shall call the meeting, with seven days of the receipt of the request, setting out the date, time, place and draft agenda, giving atleast ten days clear written notice for the meeting.

- xxi. **Accounts Clause-** There shall be maintained all accounts of the Trust regularly. The accounts shall be duly audited by a qualified Chartered Accountant every Year, the accounts shall be closed by 31st March.

ARTILE V (a): EMERGENCY POWERS OF THE MANAGING TRUSTEE

If an emergency situation is recognized by the managing trustee which would require immediate action beyond the powers delegated to her and the meeting of the board of trustees cannot be called or the President cannot be consulted within the time available for action, the managing trustee shall take action, and report in writing to the members of the board and the President. This type of power has not been delegated to her, or spending of funds which would normally require the board's approval. The board shall record its approval or otherwise of the action of the managing trustee, and authorize any following action.

ARTICLE VI: DURATION OF THE TRUST

- i. This trust may be extinguished at any time if the majority of the members of the board decide to do so.
- ii. **Dissolution clause-** In the event of dissolution or winding up of the trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees/ members of Managing Committee/ Government Body but the same shall be transferred to another old age home trust whose objects are similar to those of this trust and which enjoys recognition u/s 80G of the I. T. Act, 1961, as amended from time to time.
